BOARD MEMBER CANDIDATES

NOMINATIONS PROCESS

In our inaugural year, the Cooperative membership must fill all nine (9) seats of the Board of Directors. The Board of Directors will be comprised of six (6) Community Member representatives and three (3) Physicians as the Medical Profession Member representatives.

This year, we have nine (9) candidates running to fill the six open Community Member board positions, and three (3) physician running to fill the three open Physician Member board seats.

Community members may only vote for the Community Member Candidates; Medical Professional Members may only vote for the Physician Candidates. All members vote for the Nominations Committee Candidates.

After the Board of Directors is seated, they will randomly be assigned 1, 2, or 3-year terms, so that we are able to establish a regular rotation of board members going forward.

Community and Physician member candidates have submitted their applications to the CVHC Nominations Committee. In March and April, the Nominations Committee reviewed the applications, sought additional information as appropriate, and selected the candidates to put forth to the members.

It's important to note that several qualified candidates for both community member directors and physician member directors withdrew their candidacy based on the significant time commitment that the board will require in the 2025-2026 term.



VOTING - MAIL-IN OR IN PERSON

All eligible CVHC voting members may now vote by mail or wait to vote in person on June 16th at the Annual Meeting.

Community members (people with CM at the front of their member number) will cast up to **six (6)** votes for the Community Member Board Candidates. Medical Professional members (people with PM at the front of their member number) will cast up to **three (3)** votes for the Physician Member Board Candidates. All members will cast up to **three (3)** votes for the Nominations Committee candidates.

Community Member Candidate Statement:

Harold "Buck" Steele


Community Member Candidate Statement:
